

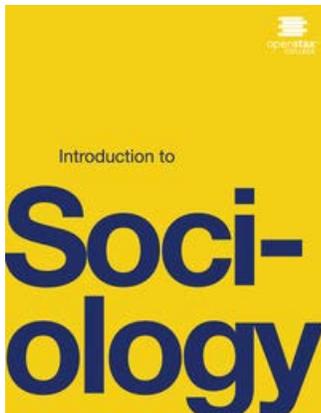


## Faculty Review of Open eTextbooks

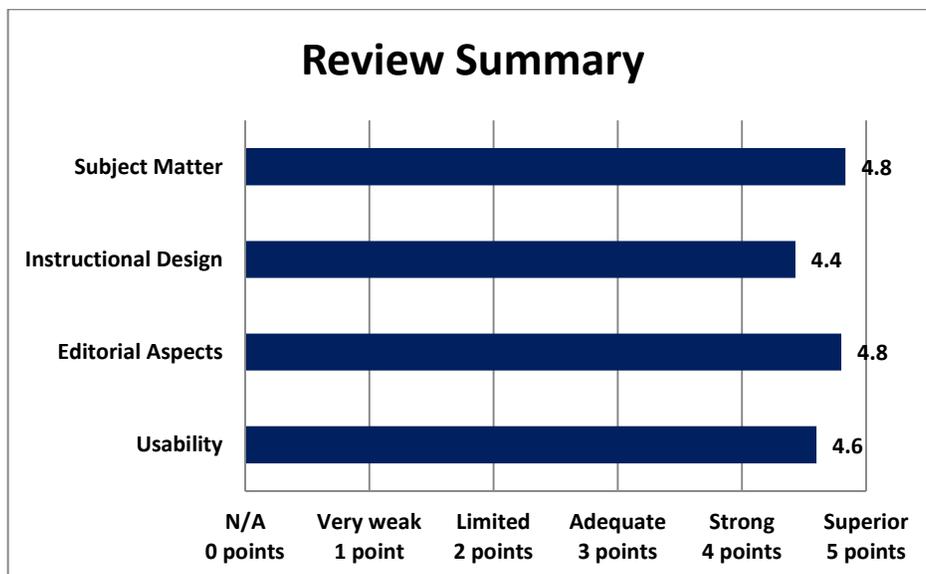

- The learning objectives at the beginning of each were succinct, and were not overwhelming for the students and the instructor. Typically, these objectives were limited to 4. They helped the student know what to expect or what is expected of him/her even before beginning to read the chapter.
- The text gives a summary at the end, and prior to that, concepts met in the book are defined. This is good for review purposes, e.g. for an examination. The text also has practice questions, which the student could use to review material in order to show whether the given chapter was understood.

- The book was very well designed, with examples, photographs, and maps are needed. Different colors were used to organize the material. I could not tell whether there is a separate test bank, but it probably exists somewhere. At any rate, even without a test bank, the instructor can easily put exams together as the semester goes on. The authors also highlight important concepts by color.

A lot of examples given seem to have the age range of the students in mind. There was no audio in the book, but there are enough colors, and graphics that lend to easier understanding--more so than other textbooks that I have seen or used in the past.
